If you are leasing your unit, please note that you must submit a letter to the HOA in support of pool privileges which includes the name and phone number of Leaseholder the name(s) of all residents and the age of all residents under 18, along with a **completed Lease Agreement Form**. **Release of Liability Agreement
And Acknowledgement of Receipt and Understanding
of the Pool Rules and Policies**

I, being of lawful age (18 years or older), in consideration for being permitted to use the Fairfield at Long Neck pool and recreational facilities, do for myself, my heirs and executors hereby release and forever discharge the Fairfield at Long Neck Association, their agents and Board members from any loss and damages, and from every claim arising from any bodily or personal injuries, death, or property damage resulting from any accident which may occur as a result of use any of the above recreational facilities.

I, further agree to indemnify the named from any loss, liability, damage, or cost it may incur due to my use of any of these facilities.

I, hereby further assume full responsibility for the risk of bodily injury, death or property damage for myself, my minors and my guests while using any of these facilities. I also understand that I am fully responsible for my minors, my guests and my tenants, even in my absence.

I, expressly agree that this release and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Delaware, and that if any portion thereof is invalid, it is agreed that the balance shall continue in full legal force and effect.

I have read the FF Pool Rules and Regulations and understand that no children under the age of 16 are permitted to use the pool without adult supervision. I understand and agree that any family member or guests using the pool facilities will also abide by all FF Pool Rules and Regulations. If anyone is reported abusing these privileges, my pool card will be de-activated and suspended for the remainder of the pool season. Also any costs to repair damages caused by a homeowner, their family or guests, will be the responsibility of the primary cardholder.

I am hereby further advised that if my FF association dues are not paid and remain current, pool privileges will be denied and/or revoked until such time as my account is and remains in good standing.

I have read the above and accept and agree to be bound by all the terms and conditions set forth herein.
